- **NEW BUSINESS:**

- Lieut. Hoiriis asked if someone would like an extra shirt, can we buy one?
- Wilton Ambulance: The town will be staying with Wilton Ambulance for another year. Capt. Borden will be our representative on the AAC from the Selectboard. The Fire Chiefs are being brought back into it too.
- Members asked Rob how the EMT class is going. He said good. They are meeting at the Milford Ambulance building.
- Laura Kostenblatt offered her expertise in getting your cell phone set up with the EMT Basic 800 questions refresher.
- The Explorers program will try to start up again on Zoom tomorrow – 3/2 at 18:30. We have 5 youths now.
- Capt. Simmons said the official run total for February is 12. 10 in the daytime and 2 at night. There were 7 fire, 7 ems, 2 motorvehicle, and 5 malicious pulls.
- Chief McQuade said he's like to get the gear orders done before it is too late. Covid screwed it up last year because the town had to cut back due to the fear of people not being able to pay their taxes. The order this year will have to be approved by the Selectboard.
- The Chief said that we need to pay attention to the waterholes in town so that we keep them open.
- Capt. Simmons asked if we can still use CMRC for water. Capt. Borden said yes.
- Chief McQuade would like to do some walk throughs in our town buildings. We need to start collecting info that GFD could use in case of a fire. We might do this Thursday evenings before wood starts.
- DEMD Boilard asked if the Chief would look at the Knox box at the library. It's in an awkward place. The Chief said he would look at it.
- There will be a blood drive on March 29th from 12-5 by appointment only. Call 800-733-2767 or go to redcrossblood.org. There will be another drive in May as well.
- Capt. Simmons sad we had a great turn-out for the ice rescue training. He said that C3 did a great job.
