## **Business:**

#### **Accept or Amend Previous Meeting Minutes**

Karen moved to accept the previous meeting minutes. Seconded by Kate. Motion passed- all were in favor.

## **Old Business:**

#### **Meadow Park:**

- <u>Sowing clover seed</u>: Should we wait until the drought shows signs of breaking? GCC will plant when the weather pattern changes in mid to late September, and will discuss irrigation at that time.
- <u>Planning and installing kiosk:</u> On hold until we have a better sense of things

#### **Pollinator Pathway:**

- Informing community about PP: Are we on the community FB page? Kate went on the community FB page and has received good feedback. Karen will talk to someone from the Harness and Drawbar club to see if they would like to prepare the seedbed at Oak Park. The GCC would like to have a meeting on January 18<sup>th</sup> inviting the public to discuss the PP. This may also be a good time to plan for the spring planting.
- <u>Designing, acquiring & disseminating PP participant yard signs:</u> They will order a few different ones and allow the attendees of the January meeting to decide which ones they would like. The GCC would like to order 6" signs for personal gardens and 12" signs for advertising.
- Publish list of recommended pollinator-friendly plants and a time line of when they bloom Link
  to town website? The GCC discussed some ideas for this. Kate will look into a website from
  go.com with the possibility of having a blog as well.
