# Meeting Minutes July 26, 2023 Recorded by Michelle Hall

7:00 pm Karen called the meeting to order.

#### **Accept or Amend Previous Meeting Minutes**

David motioned to accept previous meeting minutes. Seconded by Kate. Motion passed, all were in favor.

### 1. Ongoing Pollinator Garden Project

Dave and Shannon attended tonight's meeting to go over a possible planting location at Oak Park for a pollinator garden near the tennis court and track. Karen explained that the GCC has a contract with Moosewood Ecological and are able to purchase started plants for a community planting event through them. This is something that the Oak Park Committee would consider and plan. Shannon said that this event might be good during the Spring clean-up at the park.

It was recommended that work start to break up the ground now. Dave will be at Oak Park this weekend and able to meet a GCC member to stake out the proposed area. David Hall offered to help him do that. Dave said that he's had good luck with applying wood chips and horse manure on a planting bed to get it started. He thinks he can borrow a machine to rototill the soil and get horse manure to start amending the area. He will reach out to the DPW for some wood chips as well. This is all in preparation for Spring planting. Karen will contact Moosewood for a list of plants they are able to ger and will get back to Dave.

# Current Business:

- 1. Hazards at the Blacksmith parking lot
  - Research and new information Tom explained that he had talked with Ray Cilley who recommended he reach out to the Southwest Planning about this problem. He did and spoke with J.B. Mack who told him that the town would be eligible for an assessment and a possible grant to deal with this issue. Should the GCC go before the Selectboard, J.B. Mack is willing to attend and help to explain the process. He offered to help Tom with information for the formal letter to the Selectboard as well. He said that the NH Dept. of Environmental Services (NHDES) is also very willing to help with this type of thing. Kate related her positive experiences with NHDES with a buried oil tank and said that they came and removed if without any cost to her.

Shel also thinks that having a Town email address is a better solution since we are a department of the Town. Karen asked if everyone things it's a good idea to have Town email addresses and said that the cost is \$5 a month for each one. Previously we had discussed a separate address for programs. Everyone thought we should move forward with this. Karen will reach out to Aaron to see about obtaining a town email for the GCC and another for programs.

- 7. Memorial Garden at Crotched Mountain
  - Kate explained that the Master Gardeners have planted a lot of items and turned a lot of soil, Moosewood surveyed at this location. The gardeners are wanting to install signs on the mountain to explain to people what has happened at this location and what is in the works to happen with some QR codes as well. The Master Gardeners are looking for some input as to what to put on these signs. The GCC recommended that she talk with a few local folks, especially Lenny Cornwell of the Historical Society, to get more information on the history, such as the farm which was once there.
