- Capt Borden reported that all the tents larger than 20x20 had to come down and the ConVal district bought 20x20 tents for the schools.

- **NEW BUSINESS:**
- The Ozone generator has been returned and is up and running
- B&G will be cutting some trees from Oak Park
- Need coverage for Thursday nights. We have some but we are light.
- Chris Borden would like an ID tag list. If anyone needs them, let her know. (Mike Hoiriis gave the names of the ones we have and made a list for Chris)
- Thinking about replacing the pumper – NE Fire has a Marion Demo Pumper but it is \$529,000 – out of our league but it was an opportunity to see what is out there.
- Blood drive on October 30<sup>th</sup> – there will be a press release in the paper – people need to sign up.
- The air purifier is in. It has a 5 stage filtration system.
- Rob Wachenfeld was awarded his department badge.
- Capt. Batty reminded us that we should be getting an email about re-registering Post 13.
- Everyone should be done with NH protocol 8.0 by Oct 30<sup>th</sup>.
- On last Tuesdays call – an untimely death, everyone needs to know the protocol. It is treated as a crime scene. After the death is pronounced, the ME has total control of the body – do not touch.
- Capt Borden said that when Gersh takes over on the mountain that they will only take children, no adults. All group homes need to be inspected. These places will be empty for a while. Gersh will not take over until March. CMRC will run for them until then.
- Capt Batty suggested that we get in touch with the Gersh program coordinator so that we know if there are any changes in our response.
