- **NEW BUSINESS:**

- Some members asked about T-shirts. We don't have many left so send your sizes along to be considered for an order.

  - Capt. Batty said he would do some research on this PFAS issue.
  - EMD Martin suggested keeping an air cleaner going in the gear room to help with the PFAS. Fire Warden Hennessey said the gear room should be under negative pressure. Deputy LaCourse said he thought it could be done. Fire Warden Hennessey said he thought that it might cost \$1500 or so.
  - Wilton Ambulance: Members discussed how they feel about the ambulance question. The consensus was that the second ambulance is needed. If we don't have that then we aren't going to be able to take care of our town's people properly. It was noted that if we go with Peterborough, it will be permanent. We will also have to sign a 5 yr contract. Generally, members like Wilton but want the second ambulance.
  - Members asked Rob about the ladder. The reason is to get the year numbers on the sign on the building. It was suggested that we wait until the siding is less brittle.
  - Capt. Simmons said the run total for January is 15, 10 during the day and 5 at night.
  - Recertification: There are 5 members that must recert at the end of March. Capt. Batty said that you should try to get it in by the end of February. He will help anyone who needs it.
  - Deputy LaCourse announced the awards for the year. The Firefighters Association Member of the Year award goes to Rob Wachenfeld. He will receive a plaque for this. The Fire Department Member of the Year award goes to Tod Bryer. He will also receive a plaque.
  - DEMD Boilard asked if everyone on the department has gotten their second vaccine shot. Not everyone has. Those that need to can schedule it tomorrow. Some say that VAMS doesn't believe that they got the 2<sup>nd</sup> one. VAMS will send a short survey after you are done. It only takes 30 seconds to do it.
