He will give to Ray 32 **Cilley** for him to request updated plans for the planning board. 33 BSmith and RWalling arrived at 7:04 pm. 34 35 7:05 pm PCC – Ben Mowatt – Old Bennington Rd, Bicycle Business 36 Ben Mowatt was present to explain his proposal and obtain guidance from the planning board. 37 BMowatt explained that he would like to start a rail bike tour business where the train tracks are near 38 RCilley's property on Old Bennington Rd, with a small temporary structure. He wasn't planning on any 39 signage and would operate during daylight hours as there are not lights on the tracks. There would be a 40 porta potty at the location and RCilley is in the process of getting electrical hookup added to the site 41 with the assistance of Eversource. BMowatt and his two partners are working with the track owners and 42 NHDOT, along with the Federal Rail Road Commission to obtain any required permits, documentation 43 and lease agreements. The planning board asked for **BMowatt** to complete a business permit 44 application and keep them involved with the permitting process. 45
