The GCCC is requesting a change of use for its building at 12 Depot Dr so that its congregation can worship at that location. RWachenfeld posed the question to MBorden who suggested the planning board review the meeting minutes when the GCCC had previously come before the board. He further stated that the GCCC would have to meet fire, life, and safety requirements for

the area that the meetings will be held as well as for the rented apartment above the meeting space. The board discussed the options, reviewed previous minutes from 2014 and determined that a site plan review would be appropriate for the change of use for the property at 12 Depot Dr to allow for GCCC members to worship and/or meet there.
