37	MParker handed out the Year End Town Report for the planning board. MParker asked for the planning
38	board to go through it, make any adjustments and send it back to him. He will be making edits and

42	7:00 pm PCC - LLA Barbara C. Harris – Dennis D. McKenney presenting
43	MParker gave an overview of Preliminary Conceptual Consultations. He invited Dennis McKenney,
44	surveyor for the applicant, to give his presentation to the planning board. DMcKenney handed out plans

and a colored, birds eye view of the property to the planning board. He went on to explain that the Barbara C. Harris Center and the Jean D. Cernota Trust are exchanging equal amounts of land. DMcKenney explained that they are asking for two waivers due to the size of the property. They are asking for a waiver for the inch scale measurement and a waiver for the dimensions of the property lines. DMcKenney explained that the Cernota piece of property is in current use and some of the camp's piece is in current use.

The planning board thanked DMcKenney for his time and presentation. **MParker** stated that a public hearing is scheduled for February 10th at 7 pm.

7:20 pm PCC - LLA - Tom and Ginny Chrisenton

MParker opened the floor for Ginny Chrisenton to present their proposal. GChrisenton explained that they own 900-acre tree farm in Lyndeborough, as well as, 2 lots in Greenfield. They would like to change the center line between both properties in Greenfield to add more land to one of the lots. She explained that there will not be any new building lots but this would ensure that both lots can be accessed through the one current interior private road. GChrisenton explained that they are asking for an expedited review and a public meeting not a hearing. **MParker** asked for GChrisenton to submit her completed LLA Packet to the office manager and once received by the planning board, the process would be able to move forward. The planning board thanked the applicants for their time and presentation.
