34	GRainier explained that the ZBA met and were able to put together a packet to send to town counsel.
35	MParker explained that the select board has started their workshops. MParker is still working on the CIF
36	and making good progress. He should have a report for the planning board around September 2021.
37	CMamczak stated that she is now on the Cemetery Committee and is taking minutes as well as cleaning
38	up the files.

40	7:00 pm Atherton LLA – Map V5 Lot 2 & 18
41	RWalling called the public hearing to order and went over the rules for tonight's public hearing. MHall
42	stated that this public hearing was properly noticed at the town hall, post office, town website,
43	newspaper and to all abutters. RWalling motioned to accept the application. Seconded by DThimmel.
44	Motion passed 7-0-0. Dennis McKenney, surveyor for Tammelda Atherton, explained that there are 2

45	current lots, one of which is land locked. TAtherton would like to adjust the lot line on the land locked
46	parcel to include the small dwelling. TAtherton did go before the ZBA, who granted her a variance to
47	adjust the lot line as long as there was an easement for an accessway to the land locked parcel.
48	MParker asked if all lot lines followed the set backs required, DMcKenney confirmed. MParker wanted
49	to ensure that the applicant know this LLA may affect the taxes for both lots.
50	RWalling opened the public portion of the hearing. There were no members of the public attending
51	tonight's hearing. RWalling closed the public part of this hearing, the planning board has now entered a
52	deliberative state. DMcKenny confirmed that he used #6 rebar which is 60-80" long as monuments with
53	8-10" showing above ground. And that he has already monumented this property. MParker motioned
54	to approve this LLA. Seconded by RWalling. Motion passed 7-0-0.
55	MHall collected check #1829 in the amount of \$225.77 for the remaining balance of the fees for this
56	application. As well as, check #1830 in the amount of \$25.00 for the LCHIP fee. NBrown will send
57	TAtherton a 'Paid in Full' Invoice when he sends an approval letter, after all plats and mylar have been
58	received.
