This is a very invasive plant and will have to be removed with an herbicide. The Chair asked what the herbicide is called. Selectwoman Day will get that information.

The Selectboard signed a letter to the DPW department expressing gratitude and support for their hard work while the search for a new Supervisor was conducted.
