Eligibility: Farmers, Crafters, and Handmade Goods. All vendors must participate for the entire duration of the market day.

Spaces: Spaces are available on a **first come, first serve basis**. Vendors are responsible for performing their own set-up and tear-down, providing their own tables and other display materials, and removal of all trash generated by their space. (Tables and chairs may be available for use at the Meeting House, but cannot be guaranteed.)

Fee: Participation fee is **\$10** for each market day (residents and non-residents).
Fees are non-refundable.

Notification: You will receive email confirmation once accepted to the market.

Application Deadline: 4:30pm, day of market. Priority will be given to vendors that are pre-registered.

Terms for Participation

Greenfield Holiday Market 2022

1. Entry fee entitles you to one vendor space. Multiple spaces may be reserved, with fees commensurate.
2. Spaces may be shared by more than one vendor at no additional cost.
3. Fees are non-refundable.
4. Vendor set-up (i.e. table, chairs, etc.) is the vendor's responsibility. Tables and chairs may be available for use at the Meeting House, but cannot be guaranteed. All vendor items are to be displayed within these spaces, not in aisles or walkways.
5. Vendor must indicate on application if a specific space or power access is preferred. Such requests are evaluated on a first-come, first-serve basis.
6. Effort will be made to keep variety throughout the fair and direct competition at a minimum. Exclusivity is not guaranteed.
7. Set up time is 4pm of the given Market day. You will need to check in with a Market volunteer before 4:30pm or you will be considered a "no show" and we reserve the right to fill your space with another vendor.
8. Vendor is responsible for their displays, providing their own cash boxes, and monitoring their own space.
9. Vendor will remove all trash, boxes, etc. from their booth before leaving. We practice "leave no trace" in respect to our booths and surrounds.
10. Vendors assume full responsibility for any damage, loss, or theft to their exhibits/property. Vendors further agree to indemnify and hold harmless the Town of Greenfield and its officials, agents, volunteers, and employees; the Oak Park Committee and its volunteers; and the Greenfield Farmers' and Crafters' Market and its volunteers from any claim or cause relating to or stemming from participation in the Market.
